

Appendix: Detailed Reporting Characteristics

Introduction

This appendix document is a transposition of the reporting requirements and keywords to the attention of our clients. It describes the structure of the transaction-related elements from the MT940 Reporting (Tag 61 and Tag 86) to contain the attributes as defined in our International Payments Product Offering.

As such, we provide definitions for all possible operation codes from the International Payments offer. We also paid attention to mention changes and evolutions brought by our new payment platform. Movement code changes are also described at the end of this document.

All the models have a column "Key Word" indicating the key word and the format of the value provided after that key word. The value definition is explained here:
